Sub: S.E. Dept., - Request for sanction of Compensatory Casual Leaves (CCLs) to the Teachers who worked for National Population Register (NPR) during the Public Holidays in the districts and 7 days of Earned Leave who worked in the Hyderabad district (in lieu of the work done in the Summer Vacation) - Orders - Issued.

In the reference first cited, a request was made to grant Compensatory Casual Leave (CCL) to the Teachers who worked for the National Population Register (NPR) updation work during the Public Holidays in the districts and to grant Earned Leave (EL) to the Teachers who worked in Hyderabad District for the same work during the Summer Vacation. The issue was examined based on the precedents issued in this regard from time to time.

2. The first round of National Population Register (NPR) updation work was done from 16.11.2015 to 31.12.2015 in all the districts except Warangal district. In Warangal district due to the Bye Elections, this work was delayed and instead of starting from 16.11.2015, it started from 07.12.2015 and ended on 31.12.2015. During this period from 16.11.2015 to 31.12.2015, total public holidays are coming to 9 (nine) days. In respect of Warangal district, from 7.12.2015 to 31.12.2015, total public holidays are coming to 7 (seven) days. In Hyderabad district, the work was taken up from 01.04.2016 to 30.04.2016 in which public holidays are 7 (seven) days and Summer Vacation days are 7 (seven) days.

3. In the references 3rd cited, the Director of School Education, Hyd., has requested to issue orders to sanction of 9 days of CCLs to the teachers who worked for NPRs during the Public Holidays in the districts other than Warangal and for Hyderabad district 7 (seven) days of CCL and also to grant Earned Leave for 7 days to the Teachers who worked in Hyderabad district in lieu of the work done in the Summer Vacation.

4. In the Govt., Memo 4th cited, the Director of School Education was allowed to give 4 days CCL in lieu of Training Classes attended by the Teachers for Gram Panchayat Elections during the Public Holidays w.e.f.27.9.2000 to 30.09.2000.

5. In the reference 5th cited, vide G.O.Ms.No.161, Education (Services-V) Dept., dt.14.11.2000, the Government delegated the powers to the HODs to reserve proportionate leave to the extent the teachers under their control are prevented from utilization of Summer Vacations due to attending Enumeration, Preparation or Revision of Electoral Rolls and Census etc. based on the Certificate issued by the appropriate Appointing Authority and that Earned Leave need not be given if they are asked simply to be available at the Headquarters.

6. Therefore, Government hereby accord permission to the Commissioner & Director of School Education to sanction 9 (nine) days of Compensatory Casual Leaves (CCLs) to the Teachers who worked in the erstwhile districts for National Population Register (NPR) work other than erstwhile Warangal and Hyderabad districts. 7 (seven) CCLs to the Teachers who worked for NPR work in erstwhile Warangal district. 7 (seven) days CCLs to the teachers who worked for NPR work in Hyderabad district and 7 (seven) days E.Ls. in lieu of the NPR work done by the Teachers in the Summer Vacation in Hyderabad district. This will be sanctioned based on the Certificates issued by the Tahsildars and Deputy Commissioners of GHMC concerned who allotted this work to the Teachers concerned and to whom the Teachers concerned submitted the updated NPR.


7. The Commissioner & Director School Education, Telangana, Hyderabad, shall take necessary action in the matter, accordingly.
